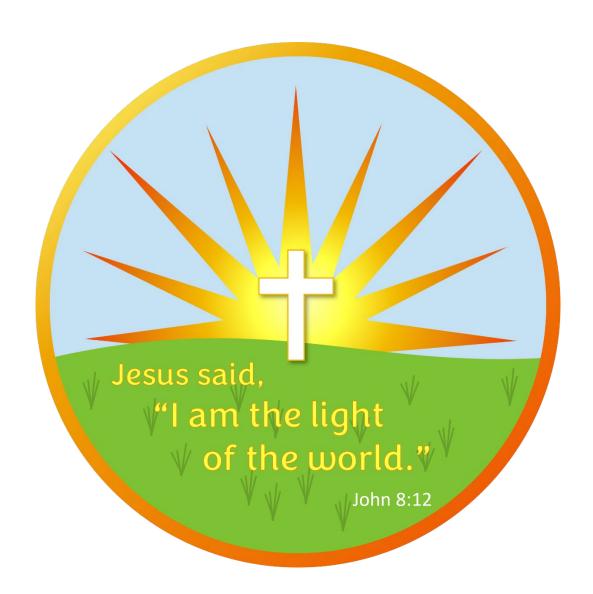

#### **December 10, 2023**

- Presentation and vote for the approval of the 2024 proposed budget as presented by the Council to the Congregation
- First ratification of NHELC Constitution updates/changes as presented by the Constitution Committee with Council approval of the proposed changes

Pastor Scott provided an opening prayer.

Vice-president Rothermel announced the tellers for today as George Trowbridge, Bryce Manthorne, and Doug Taylor.

Vice-president Rothermel requested the tellers to distribute ballots to voting members.

Treasurer Edward Becker presented the 2024 budget overview.

Vice-president Rothermel provided an overview of the Constitution changes.

Vice-president Rothermel requested the congregation to mark their ballots.

Vice-president Rothermel requested the tellers to collect ballots.

A motion was called to adjourn the meeting. Harry White provided the motion, Scott Repa seconded the motion. The motion was carried and the meeting adjourned.

The benediction was provided by Pastor Scott.

#### Voting results:

- 73 total votes were collected
  - o 73 "yes" votes to approve the 2024 budget.
  - o 72 "yes" votes and 1 "no" vote on the first ratification of the Constitution changes.

#### **PASTOR**

— Report

#### "2023 - A Return to Normal?"

With a solid year of the pandemic restrictions lifted, the world and this community expected, I believe, to return to normal. However, I also believe the definition of normal changed. Each day one is coping with how the new definition of normal affects their lives. The faith community is affected as well.

With the advent of live and recorded worship streaming, we witness and are coming to terms with a live in attendance community and a remote community of worshippers attending live and/or at a time where one's soul is ready to worship. And the good news is, we met that challenge in 2023 by installing and operating a new sound and video system in the sanctuary. Thank you all who supported this fantastic addition to our worship space.

Change also was witnessed in the amount of hunger the recent economic condition has evolved since the pandemic has ended. However, we as a foundation of this community have met the challenge and have steadily averaged delivering 150 meals per day. These meals mean someone can get medication, achieve better grades at school, and maybe most of all, receive a personal contact by one of our drivers which communicates that the person receiving the meal is worthy of God's love.

God's love is very much present also in our reformed Christian Education program of JAM (Jesus And Me). Each week joyous music resounds throughout our education wing as the students kick off each Sunday with praise to our Lord! Thoughtful attention is given to age-appropriate settings and our youth are helping lead the groups, creating a bond throughout generations. The youth are also active in building relationships with God and themselves through events and gatherings.

Praise is being realized as well in worship with the successful rollout of a blended worship by our Worship Planning Team. A worship that both young and old can be together in music and praise. This creation has allowed our once divided community to be one in our worship to God as we are inclusive of all ages, choirs, and bands in gathering as one in worship.

Gatherings were also witnessed for adults as well, with a kick-off event involving carols and mission supporting the homeless in our community. This event was a springboard for gatherings in the future to focus on fellowship, adult specific challenges, health, and wellness education.

Yes, the new normal is changing a lot of what used to be. And given who we are, that's a good thing.

Our administration of this community has met the challenges of post pandemic as well. With the advent of remote membership participation, changes in the constitution of our ELCA governing body, notices of meeting via electronical means, and other resulting administration changes have made it necessary to create a new NHELC Constitution. This challenge was met as well with the creation and initial ratification. Other administrative needs were addressed with the improved endowment partnership in investment performance and administration, comprehensive financial auditing, improved payroll management, and streamlined payments.

2024 will not be without its challenges as well, the world is entering into a time where three major wars are escalating strife. For most communities, it would be all encompassing; however, as we at New Hanover Evangelical Lutheran Church support the world crisis with our benevolence, we are also planning on meeting the challenges here at home. Initiatives are underway to begin a learning center for families in our underutilized facility.

A Christian focused Family Learning Center is being developed to address the needs for a growing community of families needing preschool, Kindergarten enrichment and childcare. Our facility has the space to support many families and bring God to their children. Studies are underway to establish the feasibility of this great mission to our community as the community is about to see growth in family dwellings.

With the growth of our community population, initiatives are also underway to become the place where people can be most welcome in worship and mission. The Reconciling In Christ (RIC) program is focused on ensuring the welcome, inclusion, celebration and advocacy for all people. This journey together will bring us to the realization of what Christ meant by loving your neighbor.

These are not the only initiatives as our Garden of Hope team is planning to expand to meet the growing hunger demand, new worship initiatives are underway to express our musical and liturgical offering to God in more expressive ways, and our most critical demand is that of inviting and enlisting volunteers and church leadership on committees, boards and council (a joint project that involves us all).

Yes, 2023 was a challenge, and 2024 promises to be challenging as well. However, I believe as we have done for 323 years, we will look forward and continue to make history and not dwell on our past. Our mantra of NHELC Loving Our Neighbors has never been more needed than now. Please join me as we bring God into this community in 2024.

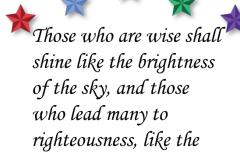

#### CHILDREN FAMILY & YOUTH MINISTRY

Report

We had a great 2023 for our JAM program and Children, Family and Youth Ministries. We began 2023 with some game nights and opportunities to socialize, something that we had been missing the past several years. The synod restarted a popular event, Box City. I was able to be a part of the planning and we did not have youth participate, but hope to do so in the future. Box

City is an excellent night with lots of learning opportunities

and fun.

Over Lent, I was able to run an online devotional group on Facebook. We had twelve people participating in the group. I hope to host a group again in 2024. In February I also hosted four weeks of a Lego club for Home and Cyber School students. We had a group of kids come in each week to play and just have fun being together.

In March 23 hosted a Prayer Fest on March 9<sup>th</sup>. One of our largest events of the year was the Egg Hunt on April 1<sup>st</sup>. We had over 105 signed up to attend and at least that showed up. While our weather was not cooperative, everyone had a great time. We capped off our "academic" year on June 4<sup>th</sup> with our Affirmation of Baptism for our Catechism students. We had eight students take the Affirmation of Baptism. In June we also had an end of year school party for the younger kids and had pizza, cookies and drinks for a fun afternoon. The highlight of June was of course our Stellar Kids Camp where our kids got to experience an out of this world week. We had over 55 kids and A LOT of adults participating and truly were able to "Shine Jesus Light"!

In July we took a group of 19 to the Reading Phillies game. On 7/11 we had an event called "Hot Wheels and Cool Treats" and we had at least eight families come out. The kids got some bike safety tips, participated in a bike rodeo and had some popsicles. July ended with a bang with Camp Falckner. It was a crazy weather week this week, but Lindsey Waltermyer and her team of adults pulled off a wonderful week!

This year we revamped our Catechism program and combined with St. James Pottstown and Limerick, St Lukes Obelisk and Gilbertsville. It is a much larger group and the kids like being around other kids! The classes rotate between four churches and the leaders change.

This year we have been able to split the elementary school JAM students into two groups pre-k through 2<sup>nd</sup> grade and 3<sup>rd</sup> through 5<sup>th</sup> grade. This is thanks to some new JAM volunteers and it



would not be possible to do it without them! This has been a great change for our kids so they can have more age-appropriate stories and discussions.

In October we hosted a Pumpkin Frolic for 32 people and we did the First Communion at the end of the month and had six kids participate in the class and taking their first communion. December had a very successful Advent/Christmas Craft event and we topped off the year with a Stellar Christmas Pageant.

Our Family ministry program is doing well! We hope for a great 2024, with some familiar and some new events. I could not do any of this without the excellent volunteers that help me out with these events! We can always use new volunteers for these events and to make this ministry successful. We are looking forward to our 2024 Scuba Kids Camp and we are hoping to start a more active baby/toddler parent group. Nikki will also be hosting a GriefShare support group. We will be planning another fun "Meet Me At..." series in the summer of 2024.

#### **GARDEN OF HOPE**

Report



The Garden of Hope continues the mission "GROWING FOOD, FAITH, and FELLOWSHIP to ENRICH LIVES!" It is supported by NHELC's Food Ministry committee and Trellis for Tomorrow. Beginning in March, volunteers gathered in the garden to clean up and prepare for the spring planting. Then on Saturday, April 1<sup>st</sup>, we planted the spring crops on a rainy morning. Our youngest volunteers were cub scouts who joined us for this first planting of the year. Even though our seedlings were hardy varieties, they could not withstand the frosty temperatures during that first week. A small crew gathered two weeks later to replant the beds which had not survived. Spring was a real challenge in the garden as the plants faced both an early draught and flooding rains.

Despite these challenges, the Garden of Hope continued to thrive.

A variety of special activities was hosted by the Garden of Hope. Our first was an educational activity—a Compost Clinic. Community members joined in learning with members of our congregation as David Ryle from Trellis explained the benefits composting has on our world and how to successfully compost matter that can then be used to enrich the garden soil. A few weeks later, we had a honey jarring workshop led by Richard Hiltner who cares for the bees that pollinate the garden. YUMMY! Then in July, we learned about organic pest control at a Disease and Pest ID Clinic with David Ryle. We enjoyed our usual "Meet Me in the Garden" fellowship activities which included dinner and light gardening.

In addition to our planting sessions and special activities, volunteers gathered regularly on Monday and Wednesday mornings throughout the growing season to care for the beds, pull weeds, harvest and package produce which was then shared with our Loaves & Fishes ministry or local organizations which feed people in need. In addition, our garden composting area was expanded from two to six composting bins thanks to an Eagle Scout project. I appreciate all who used their hands to do God's work! I am especially thankful for Janet Smithson, Doug and Betty Senne, and Bill Allen who regularly volunteered in the garden.

Lettuce, collards, kale, Swiss chard, beets, radishes, onions, carrots, butternut squash, bell and hot peppers, cabbage, cucumbers, eggplant, tomatoes, and zucchini and more grew in the garden. In all almost 3,200 pounds of produce was harvested and shared. These donations were accepted with heartfelt gratitude.

God is good! In addition to the bountiful harvest, we were blessed this fall to receive a \$50,000 PA Urban Grant which will cover 85% of our costs to expand and improve the Garden of Hope in 2024. This expansion brings so much more HOPE for those in need. Consider joining us in the Garden of Hope this coming year! ALL are WELCOME!

#### PEER SUPPORT MINISTRY

- Report

The ministry saw a transition in focus to effectively help our neighbors. As pandemic restrictions lifted, the weekly in-person and zoom meeting demand located at our facility diminished to the point of no attendance. The Email and Phone hot lines were retained and have been effective. In addition, the board did a survey and did a trial of providing support in Pottstown. The remote support was not effective, and the board saw the need to support other areas in addition to recovery.

The new initiatives included a "Help Resource" announcement in the bulletin to help people access Mental Health, Substance Use Disorder recovery in addition to grief support, organize, staff and initiate the GriefShare weekly meetings beginning in January 2024, and a First Aid for Grief workshop scheduled in March, 2024. Daily support in helping people deal with grief, recovery and/or suicide prevention and continued care is being communicated and addressed by Pastor Scott, with help from other health professionals. The current system of support has been effective in meeting the needs of our faith community and neighbors.

The Board wishes to thank everyone who supports this vital ministry in prayer and donations.

#### **PRAYER MINISTRY**

We thank our treasurers for their fine record keeping and the care taken to manage our treasuries.

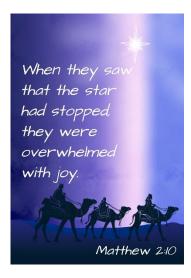

The mission of the NHELC Building Fund is to identify and finance the capital needs of New Hanover Evangelical Lutheran Church in partnership with the standing committees of the congregation and congregational council. Work funded through the NHELC Building Fund over the years includes highly visible projects such as our building loan repayments, Swamp Pike sign, and parking lot refurbishment and a host of less prominent, but equally critical, capital maintenance projects. During 2023 the primary project financed through Building Fund was the replacement of deteriorating windows in a portion of our education wing with new, more energy efficient, models.

It should be noted that additional major capital improvements remain in progress with outstanding payment balances that have been funded through non-building fund sources. These include the education wing HVAC, sanctuary electrical system upgrade, and sanctuary audio/visual system upgrade. These projects are being financed through dedicated funding mechanisms and contributions established with approval of the congregational council.

The NHELC Building Fund is thankful for the financial support it receives from the congregation, allowing it to fund the preservation and enhancement of our church facilities. Our congregation is blessed with an amazing physical resource in our building and grounds. It is only through your care and investment that we can ensure it remains a vibrant hub for the many ministries that utilize the church far into the future.

We are grateful for the support of the many people who work tirelessly throughout the year to execute the repair and maintenance of our building and grounds. As we participate in the many activities that take place at NHELC throughout the year, the benefits the church facilities provide to the congregation and the surrounding community are readily apparent. Hearing no suggested or required revisions through the process, the Congregational Meeting second vote to adopt will be held at the Annual Congregation Meeting on February 11, 2024 at 10 AM following the church service.

The committee's work will continue on the By-laws to coordinate them with the new constitution, and eventual submissions to the congregation for approval.

#### **ENDOWMENT FUND COMMITTEE**

Report

Members are Don Wirt, chairperson, Allen Care, Bryce Manthorne, Jeff Wise, and Herman Richard.

The Endowment Fund policy adopted as a continuing resolution by the Congregation Council in 2022 was tested this first year of use. As a Continuing Resolution, the document can be revised as determined by Council. We found it necessary to amend the policy in regard to the method of distributing earnings to be transferred to the general fund. The affected policy provision revised is as follows:

**D.** Annual Distribution – The fund shall distribute to the General Fund, on an annual basis, 4% of the average 3-year total account balance. When the values are available, the amount should

be calculated by taking the average of the rolling last 12 quarters account values. If necessary, annual balances can be utilized until 12 quarter account balance observations are available. Once the annual calculation is determined, the fund shall distribute 25% of that amount, each quarter to the general fund.

The above revision was approved by motion at the December 2023 Council meeting.

Another committee accomplishment this year was the purchase of an Endowment Fund Contributors plaque which will be hung in the Welcome Center in early 2024.

The Endowment Fund committee recommended a display plaque be purchased for the listing of all contributors' names. No dollar amounts will be included. Just the names of members/families who donated contributions to be used for investment in the future of NHELC. The plaque will have space for 150 name plates. The plaque will have 60 name plates engraved for the current list of contributors. The plaque purchase will be from undesignated funds from the Memorial Fund. Additional plates for new contributors will be engraved and added to the plaque.

Most importantly, the committee has been in regular communication with our financial advisors in reviewing investment performance and trends of markets influencing our investment values. The Endowment Committee thanks Cornerstone Advisors Asset Management, LLC, our financial advisors, for their expertise in helping us to manage the Endowment Fund.

2023 was a busy year for the Scouts of New Hanover's Cub Scout Pack 367 and Scouts BSA Troops 367B (male unit) and 367G (female unit). All Scouts, from youth of elementary school age to young adults preparing to head off into the "real world", were able to engage in a wide range of learning opportunities, fun, and adventure through the high-quality programs, grounded in the traditional values of Scouting, offered by New Hanover's three chartered units.

The Picnic Grove is an historical extension of our church ministry and is available for use by church members and affiliated organizations. We continue to partner with the Fellowship Committee to provide opportunities for fellowship both at the picnic grove and the church to include our members and our neighbors.

Following are highlights and events during 2023:

• The annual Soup Sale was held on January 29 and offered beef vegetable, chicken potpie and chili. This event generated a profit of \$508.

- The annual Spaghetti Dinner was held on March 11, open to the public with eat in or take out options. We served 132 eat in meals and 25 takeout meals for a total of 157 meals. This event gave us a profit of \$666.
- There was a Spring Clean Up event on April 23 in the picnic grove to rake leaves, pick up tree branches and clean the kitchen and bathrooms. We had a fantastic turn out from the Scout Troop and church members. We ended with providing hot dogs, snacks and drinks.
- Our next event was the Chicken Dinner on May 20, open to the public with eat in or take out options. The event was a success and gave us a profit of \$917.
- On July 23 the worship service was held in the picnic grove followed by breakfast for everyone. This was a nice kick-off for Camp Faulkner.
- The Great Swamp Picnic was held on August 26 at the grove where we have the opportunity to greet new friends from the community and welcome back family and friends we haven't seen for a while. We had many volunteers help with food prep, set up, serving and clean up. This year we brought back the hot roast beef sandwich, which we served 152! We served 305 meals in the dining area and 186 takeout meals, for a total of 491 meals. We realized a profit of \$1,890. There was also the attic treasures yard sale and kids' games for enjoyment. The Boyertown Area Alumni Marching Band provided entertaining musical selections for the audience. It was a wonderful day enjoyed by all.
- The Rally Day Congregational Picnic was held on September 10. The Picnic Grove and Fellowship Committees worked together to provide a relaxing and enjoyable day for our church family.
- Our last event for 2023 was the Roast Beef Dinner on November 11 in Fellowship Hall. This event was open to the public with eat in or take out options available. We served about 120 meals and had a profit of \$1,256.

Maintaining the grove and its facilities throughout the year requires an ongoing commitment from committee members and other volunteers. We oversee grove rentals, leaf raking, tree branch removal and provide maintenance of the buildings, playground area, equipment and property. The NHELC Cub Pack and Boy Scout Troops have also helped with grove upkeep. We also encourage new and current church members to join our fun-loving committee to help plan and implement activities at our beautiful grove.

#### PROPERTY COMMITTEE

- Report

The Property Committee oversees and directs all of the cleaning, maintenance and improvements to the church buildings and grounds, as well as the Church's Insurance Program.

The number of property projects tackled in 2023 were minimal due to limited funding and challenges with contractors. Projects include:

- Replacement of (18) 70-year-old windows across the back of the choir rooms and classroom wing after determining it was not cost effective to repaint them and we'd save on heating costs.
- Removal of rotten louver over main church door to use as pattern for a replacement (2022). Replacement pending.
- Replacement of two boiler circulators.
- Final completion of Sanctuary Audio Visual Electrical project, which provided a new sound, video and lighting control system in the sanctuary. Also included in the project was the updating and rewiring of the entire sanctuary electrical system.
- Requested proposals for Property, Liability, Automobile, Umbrella and Workers Comp Insurance, and upon evaluation of coverage and pricing selected Brotherhood Mutual as our new carrier.

The committee is especially grateful to Thomas Faust who continues to look after and care for our building in his part-time role as Facility Maintenance Supervisor.

We transitioned to a new cleaning service, and have contracted member Jenn Boyer beginning 1/1/23. The building has not looked better in the recent past, so please thank Jenn for her efforts when you get a chance.

In 2024 we'd like to repaint the interior of the Fellowship Hall and adjoining area as well as some exterior windows as funds allow, so please contribute to the Building Fund which is our resource for most small to medium property projects.
