Special Congregational Meeting

- CLOSED meeting (no open discussion)
- Congregational vote (ballot statement on next slide)

Special Congregational Voting Ballot VOTE:

The Congregation is voting to approve (YES vote) / deny (NO vote) Council action allowing expenditures for the NHELC Learning Center ministry planning process and feasibility study continuation above the Constitutionally imposed limit of 3% of the 2024 annual budget total. The amount for this approval is being capped at \$50,000 above the 3% limit. Any future expenditures that would exceed this amount would require additional Congregational approval.

Special Congregational Vote Background

To date, expenses for the Learning Center ministry planning process have been well within the Council's ability to approve, however pending planning costs for the design, bid and management of the necessary construction/remodeling improvements, traffic study costs, sewer authority costs (EDUs, metering costs), and certifications will exceed the 3% allowable by the Constitutional policy (~\$13,000 is the 3% limit for 2024 budget). Council does expect to hold a second Special Congregational meeting in a few months once the preliminary plans have been vetted and final cost estimates and financial plan are ready to be committed to.

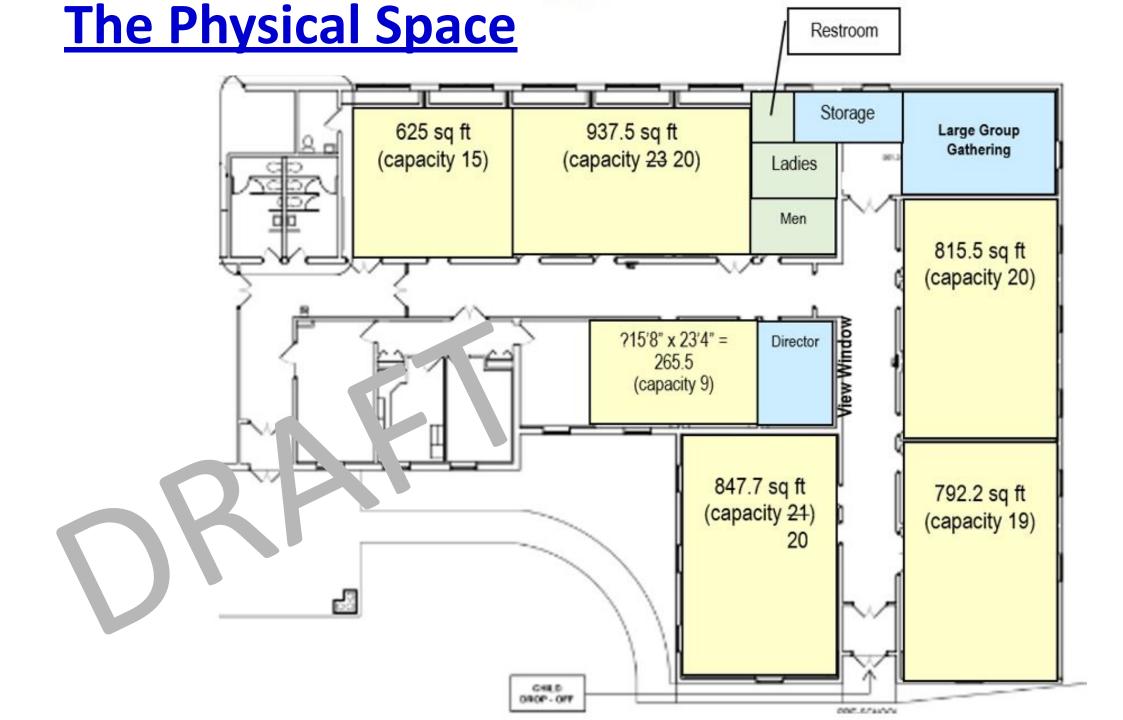

Financial Statement

- Learning Center ministry is planned/expected to be a SUSTAINABLE ministry
- Seed funds are needed for startup and initial operational costs.
- Cash need estimated to be ~\$250,000
- Seed funds expected to be repaid in 5 years
- Loan terms per Endowment policy adjustable rate based on current money market rate (~5%)

Financing: Pre-Construction Expenses

- Bidding and Construction Administration Services
 - Richard Kapusta and Co., Architects and Planners
 - •\$9,760.00 (fixed fee)
 - Covers design, bid, construction management

Financing: NH Township Traffic Study

- NH Township Requirement
- Traffic Planning and Design, Inc. of Pottstown Proposal
 - Retainer \$3,700
 - Flat Fee \$10,600
 - Possible additional costs for changes, copies, evening or weekend meetings
- NH Township Traffic Impact Fees (TBD)

Financing: NH Township Sewer Authority

- Currently have 2 EDUs
- Reduced Flow Agreement
 - Before opening day: Purchase 3 EDUs at \$3,469 per EDU (\$10,407 in total)
 - Defer purchasing additional EDUs until flow is determined to exceed the average daily flow allotments of the purchased EDUs
- Expenses to hook up two flow meters on water sources
 - All water usage less water used in garden and cemetery
 - Estimate \$2,800 to \$4,000

Current Financial Source Plan

(vetted by Council, Endowment, Finance)

- General Fund loan to get started (repaid from Endowment as needed)
- Donations, Bequests, Grants
- Endowment Fund loan up to \$200,000
